Thank you for your email and your interest in public arts in the Toowoomba community.  
I am aware of some of the community work of the Queensland Arts Council and I commend you for the role you play in extending this to the Toowoomba region.  
I am familiar with ACT's Avant Garden project which I think was a creative and clever way to ensure Toowoomba was able to uphold its image as the Garden City, even after the long drought had taken such a toll on the region.  
I see the arts as fulfilling that type of role in our community. That is, enhancing aspects of our identity and finding new ways to express it, both for the benefit of the local community and as a means of attracting visitors to our city. I also believe "the arts" should be about more than galleries or paintings or high-level design, but should also be about "working" art that people can relate directly to their lives. Clearly, Arts Council Toowoomba Inc shares that view.  
I must admit that I am not briefed on the full details of the Toowoomba Regional Council Public Arts Policy, but I agree that it is a policy that a city the size of Toowoomba should pursue.  
If elected to the Toowoomba Regional Council I would be interested to sit down with members of ACT to discuss this further, in particular how to make the policy a reality because I appreciate that you don't want the Public Arts Policy to simply sit on a shelf gathering dust where it's of no value to either artists or the community in general.  
I also look forward to learning more about the Splashing Back project you have referred to, because just like Avant Garden it sounds like another great example of using public art as an expression of our region's identity. From what you have explained in the email, it sounds to me like a positive project to complement the existing flood memorial. Again, if elected to TRC I would like to discuss this project in more detail and talk more about what role you think the TRC should play in facilitating public art.
